COVID Protocol

In light of the concerns surrounding the Current COVID-19 pandemic, we are taking all of the necessary precautionary health and safety measures to safeguard both our guests as well as our loyal staff.

Given the nature of our industry, we interact in close proximity to our guests. Whilst our Hotel has always maintained strict hygiene standards, we have implemented additional measures to protect our guests and ourselves.

1. Screening of guests on arrival has become necessary in accordance with the national state of disaster. Therefore, in order to prevent an infected person from checking into the hotel guests will be required to:
 - a. Complete and sign a check-in questionnaire
 - b. Allow their temperature to be scanned with a thermal scanner
 - i. If a guest's temperature falls within the normal range and they do not show any symptoms they will be required to sanitise their hands and proceed to check-in.
 - ii. If a guest's temperature is high (actual temperature at screening should not exceed 37.5 degrees Celsius) and/or they have symptoms of the virus they will not be allowed to check-in and will be referred to a medical facility.
2. Wearing masks where necessary and sanitising throughout the processes of checking in guests, completing documentation and serving patrons etc.
3. Having hygiene stations throughout the property, which include hand sanitizer with a minimum of 70% alcohol content.
4. Regularly cleaning and disinfecting frequently touched objects and surfaces.
5. Sanitising sprays used on all our equipment and surfaces.
6. Displaying instructional posters on how to prevent the spread of the Coronavirus.
7. Maintaining a safe distance between tables in our Restaurant and Outside areas.
8. Strictly limiting group sizes in accordance to Government announcements from time to time.
9. Food and Beverage:
 - a. Public consumption of liquor during the national lockdown is strictly prohibited in line with the Disaster Management Act of 2002.
10. Deliveries from suppliers will be strictly monitored as per protocols.

The National Institute of Communicable Diseases (NICD) Hotline is available to all staff and guests. In the event that anyone feels ill, the South African Department of Health advises **first phoning the helpline** rather than going straight to a medical facility, to prevent potential contamination.
